# ADULT EDUCATION

## OBJECTIVE:

Provide returning MPRI parolees assessment, referral for appropriate assistance, preparation/subsidy for GED testing, when not completed within facilities.

# DOMESTIC VIOLENCE TREATMENT

## OBJECTIVE:

Assist with cost of participation in Domestic Violence Treatment, when necessary.

## OUTCOME:

All MPRI parolees with Domestic Violence Offense are able to receive treatment through MDOC contract.

# SEX OFFENDER SERVICES

## OBJECTIVE:

Provide supplemental funding to increase availability to Sex Offenders.

## OUTCOME:

All MPRI parolees with CSC (Criminal Sexual Assault) Offense are able to receive treatment through MDOC contract.

# VICTIM SERVICES

## OBJECTIVE:

Provide support for community education

## EXPECTED OUTCOME:

Better access to services for victims and for those returning MPRI parolees with a history of victimization.

## ACTUAL OUTCOME:

No funding or assistance has been requested to date.



# ENTITLEMENT PROGRAMS

## OBJECTIVE:

Provide assistance pre/post release to facilitate acquisition of entitlements.

## EXPECTED OUTCOME:

All returning MPRI parolees, who are eligible for entitlements, will have assistance in attaining necessary documents to make application.

## ACTUAL OUTCOME:

All returning MPRI parolees, who are eligible for entitlements, begin application process for documentation prior to release, including signing release of information for medical/mental health/substance abuse treatment records.

# LAW ENFORCEMENT

## OBJECTIVE:

Increase Law Enforcement ability to participate in Night Hawk program.

## EXPECTED OUTCOME:

Night Hawk will be continued and supported by all branches of law enforcement.

## ACTUAL OUTCOME:

Law Enforcement is able to provide ride-a-long whenever a parole agent is available.

# COLLABORATIVE CASE MANAGEMENT

## OBJECTIVE:

Service Coordinator assists agents and parolees with service coordination, assures accurate data collection, maintenance and reporting.

## EXPECTED OUTCOME:

Effective and efficient collaborative case management.

## ACTUAL OUTCOME:

Service Data is gathered, tracked, maintained and reported. Transition Teams and Parole Agents are effectively linking MPRI parolees to necessary services prior to release or as identified after release.

# MPRI Statewide Update

- **20,312** engaged from MPRI inception through September 2009 in IRU or MPRI release cohorts.
- **19,105 (94%)** of these had been released to parole by the end of July 2009.

# Targeting Parolees Most Likely to Fail on Parole

- Offenders who have a prior history of parole failure are **24%** more likely to fail again.
- **51%** of MPRI cases released through September 2009 had a history of prior parole failure.
- Only **35%** of all paroles in the 1998 baseline year had a history of prior parole failure.

# Return Rate Improvement

- MPRI outcomes through September 2009 show a 32% relative rate reduction in total returns to prison
- **2,083** fewer returns to prison than baseline expectations so far (4,408 actual vs. 6,491 expected).
